RATE SHEET FOR EAGLES WINGS 1 & 2

Eagles Wings currently provides for 2 levels of assisted living services. Upon admission, a plan of care will be created for the resident and services will be provided based on their individual needs. Below is a general description of each level of care along with additional costs as applicable.

Each level of care includes a single or shared bedroom (based on availability and individual needs), hospital bed, linens, dresser, nightstand, and lamp. Room and board is included in these fees and covers meals, utilities, cable, and basic internet.

Level 1 Care – Eagles Wings 1 & 2

In addition to basic furnishings and Room and Board, level 1 services include necessary transportation, laundry, 24-hour medical staff assistance, emergency assistance and opportunities for recreation. These services include staff assistance with activities of daily living, medication administration, and health-related services. Services for level 1 care do not include two-person assistance or one on one care.

Level 1 daily rate - \$225.00 per day

**If a resident at Eagles Wings 1 is showing progression toward needing Level 2 Care, arrangements will need to be made for transfer to Eagles Wings 2, if possible, or another facility that can provide for the needed level of care.*

Level 2 Care – Eagles Wings 2 only

In addition to basic furnishings and Room and Board, level 2 services include necessary transportation, laundry, 24-hour medical staff assistance, emergency assistance and opportunities for recreation. These services include staff assistance with all activities of daily living, medication administration, and health-related services. Services include two-person assistance or one on one care, whether occasional or on a regular basis.

Level 2 daily rate - \$250.00 – 300.00 per day

Respite Care – Up to 3 months temporary admission

Respite care may be either Level 1 or 2 Care, but residency is expected to be 3 months or less.

Respite Care daily rate - \$250.00/day

Additional Costs

Additional costs include but are not limited to: costs of medications, vitamins, additional food requests above and beyond the determined menu and dietary needs, internet service beyond what is provided (if a resident wants to stream videos, etc), and other personal requests made by the resident. Upon request, Eagles Wings may purchase items on behalf of the resident and will add these receipts to their monthly statement for reimbursement.

Delayed Admission (Reserving a Room)

When a new resident has been accepted, but admission cannot take place immediately, the room may be reserved at half the contracted daily rate.

Other Forms of Payment

If a resident has private long-term care insurance, Eagles Wings may be able to accept it. We will work with the insurance company to determine the requirements and whether this is an option. Most insurance options require the resident to pay up front and then will reimburse some or all of the costs, depending on the individual insurance policy.

If a resident cannot afford the rates listed on this sheet, they must qualify for the Alaska Medicaid Waiver program. Eagles Wings will accept General Relief payments only while a resident is in process for the AK Medicaid Waiver.
